If the home municipality grants the application and thus is responsible for the student's costs for sfi in Stockholm, the following applies:

The student is informed that inter-municipal compensation has been granted. Registration for studies is made in contact with the Adult Education Center. Identification must be presented. The Adult Education Center conducts an initial survey, after which the student can choose from the organizers who have the applicant's planned course.

The following organizers offer intensive studies in Swedish on behalf of the City of Stockholm:

Invoicing takes place semi-annually (at the end of June and December) and refers to the study periods November – April and May – October, respectively.

If a student fails to attend the so-called planned course start, the home municipality will be charged a fee of SEK 1,000 for costs that Stockholm has for tests, possible interpreters and compensation to the organizers for failed students.
